



Update for Applicants

September 24, 2021

- NNAS has extended the expiry date until December 20, 2021 for all applications that were to expire on or before December 20, 2021. NNAS continues to monitor the situation and will be responding to changing circumstances as new information emerges.
- Applicants whose applications expire after December 20, 2021 will not be affected by this change.
- NNAS continues to accept and process applications, including reactivated applications. Update for Applicants

September 21, 2021

- NNAS is currently experiencing a high volume of applications which have become ready for review within a short time period. This may be causing delays for some applicants. While NNAS' goal is to issue 95% of Advisory Reports within 12 weeks of the last document being received, we anticipate a small number of applicants may find it will take a bit longer for their Advisory Report to be issued. That said, we are anticipating that this situation will be relatively short-lived.
- The Assessment Team has put in place strategies that are effectively managing the situation. NNAS is closely monitoring the timelines to ensure that as many Advisory Reports are issued with the 12-week goal as possible.
- If your application is exceeding the 12 week timeframe, we suggest that you monitor the status of your application in NNAS' applicant portal on a regular basis. - If it is anticipated that the issuing of your Advisory Report will take longer than 12 weeks, you will receive an email advising you of this.

Update for Applicants

August 10, 2020

- Effective August 10, 2020 NNAS will temporarily issue Advisory Reports that include language test scores that meet all requirements and are current for at least 6 months following the release date of the Advisory Report.
- Applicants are responsible for ensuring that their language test results are no older than 18 months at the time their Advisory Report is issued.
- When possible NNAS recommends submitting language test results that are no older than 6 months from the date applicants first apply to NNAS or reactivate your application. It is also recommended that applicants monitor the submission of other documents when scheduling language tests.
- NNAS' current language requirements remain in place. Please refer to the NNAS Handbook to review NNAS' language requirement.
- Applicants are advised to check with the Regulatory Body or Bodies to which they are applying to find out about any policies related to language proficiency specific to the Regulatory Body or Bodies.

Update for Applicants

June 19, 2020

- Effective June 18, 2020 the National Nursing Assessment Service (NNAS) will receive IELTS test results electronically.
- If you wrote IELTS on June 18, 2020 or later, your results will automatically be sent electronically.
- If you wrote IELTS before June 18, 2020 and you would like to send an electronic copy of your test results to NNAS please contact the IELTS test center where you took the test. All IELTS test centers worldwide are able to send your scores electronically. Please note that when you ask that your IELTS results be sent electronically, the test center may request a fee for this service.
